CIRCA initiated the Resilient Connecticut project in 2018 in coordination with state agencies, regional councils of governments, and municipalities in the Superstorm Sandy impacted regions of New Haven and Fairfield Counties. The project will generate recommendations for a *Statewide Resilience Roadmap* that includes regional resilience planning, policy considerations, and actionable priorities. In addition, science-based risk assessments will inform municipal to regional scale initiatives and pilot projects to tackle challenges of future storms, sea-level rise, and riverine flooding.

Keynote Address

Barry E. Hill is a Visiting Scholar at the Environmental Law Institute, which is a Washington D.C. based environmental law and policy think tank. Previously, Mr. Hill was the senior counsel for environmental governance of the Office of International and Tribal Affairs at the U.S. EPA. He also served as the director of the Office of Environmental Justice at the EPA, the associate solicitor of the Division of Conservation and Wildlife, and director of the Office of Hearings and Appeals of the U.S. Department of the Interior. Dr. Hill will discuss the close interrelationship between environmental justice and climate justice in the United States, and how the victims of environmental/climate injustice are potential "climate refugees." Environmental/climate justice are environmental, public health, and public policy issues. He will then discuss how attorney generals in several different climate change cases are seeking to address these issues using traditional state environmental laws, environmental justice legislation, environmental rights amendments, public trust laws, as well as consumer protection laws. Finally, he will offer valuable observations for policy makers in Connecticut.
